 - C. Director's report: Director Litjens reported the following: The Governor has ordered all non-essential business to be closed until April 29, 2020. The details are still in the works. Trustee LeBlanc asked about sterilizing books as they are returned once the library is reopened. Director Litjens acknowledged that procedures will have to be put in place and this is something she is looking into. Temporary Plexiglas separators are a possibility. N-95 masks and sanitizer have been ordered for when we reopen. Joy is looking into UV lights for the books. May not accept returns at the desk. Waiting on guidance as to how long the virus lasts on surfaces. May need new protocols in place when employees return to work. Other discussion ensued. We now have an online programming calendar and classes are starting to fill. Bob mentioned he spoke with the web developer. We are going to add a web chat interface. This will allow for a librarian to be available to patrons for a limited amount of time each day.
